Attendance Contract:

In order to remain an active participant of the after school program, you must attend regularly. Students with excessive unexcused absences will be dismissed from the program. The attendance policy is required to ensure our program goals are met for the year. Students must provide a written excuse to the Site Coordinator for after school absences. Students are expected to maintain a 75% attendance rate. The program will operate from September 7th through April 7th for a total of 97 days. In order to meet attendance requirements, students must attend at least 73 of the 97 days of operation.
